Purpose: The purpose of this agreement is to promote co-operation in teaching-learning research and other student centric activities like job placement, sports etc between the Department of the aforementioned institutions.

Types of cooperation: Through this memorandum, both parties affirm the value of institutional collaboration and agree to promote the following activities:

- Exchange of faculty members and staff as resource persons
- Participation/helping each other in research activities/conducting workshop & seminar
- Development of teaching department by learning best practices
- Student exchange initiatives between both institutions for knowledge and skill development
- Organizing joint placement activities for students
- Organizing various curricular & extra activities together
- Organizing various training activities like Personality Development, Communication Skill, internship etc.

Coordinators

Both parties shall nominate one coordinator each for effective implementation of activities under this MoU. Any disputes shall be resolved amicably through mutual discussion. At least two activities shall be organized by both the parties every year.

This agreement places no financial obligations or supplementary funding commitments on either party. These activities will be defined between head of the departments of the institution through separate communication.

Subsequent programs agreements must be approved in writing by the authorized representative of each institution.

(Mr. Rupesh Kumar Gupta, Director, Prism Group of Institutions, Bhilai (C.G.) will serve as the primary liaison between the two institutions to facilitate the development of future activities.

(Dr. Yugeshwari Sahu, HOD, Department of Commerce) will serve the primary liaison between the two institutions to facilitate the development of future activities.

Terms: This agreement will become effective immediately after the date of signature by both parties. It shall remain valid for a period of three (3) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both parties. This agreement may be terminated by either party with advance written notice of at least 30 days. The agreement may be extended by written mutual consent of renewal by both parties after the mandatory period.

The Memorandum of Understanding (MoU), written in English, is hereby signed in two (2) copies with 1 copy remaining in the possession of each institution.

This MoU does not involve any financial commitment unless mutually agreed upon in writing.
