1. Objectives of the MoU

The purpose of this MoU is to promote academic collaboration, rehabilitation exposure, and practical training for students of Psychology.

- To provide structured internship and supervised field exposure to students.
- To jointly organize workshops and skill development programs related to rehabilitation and mental health.
- To conduct seminars, awareness programs, and academic events on disability inclusion and psychological wellbeing.
- To facilitate guest lectures by rehabilitation professionals, clinical psychologists, and therapists.
- To promote experiential learning in clinical and community rehabilitation settings.

2. Areas of Collaboration

- Internship & Field Exposure in clinical and rehabilitation services at CRC.
- Workshops and Training Programs on psychological assessment, counseling, behavior modification, and rehabilitation strategies.
- Joint organization of seminars, awareness drives, and inclusion programs.
- Guest lectures and expert sessions for students and faculty.

3. Duration of MoU

This MoU shall remain valid for a period of Two (2) years from the date of signing.

It may be extended by mutual written consent of both parties.

Either party may terminate this MoU by giving 30 (thirty) days' written notice to the other party.

4. Coordinators

Both parties shall nominate one Coordinator each for effective implementation and monitoring of activities under this MoU.

Any dispute arising out of this MoU shall be resolved amicably through mutual discussion and consultation between the parties.

5. Financial Terms


This MoU does not involve any institutional financial commitment between the parties unless mutually agreed upon in writing for specific activities. However, students undergoing internship at CRC shall pay internship fees as per NIEPID norms as detailed below:

- ₹1,500/- (Rupees One Thousand Five Hundred only) for 15 days
- ₹3,000/- (Rupees Three Thousand only) for 30 days

The internship fees shall be payable directly to CRC as per prescribed procedure and applicable guidelines.
