Kamla Devi Rathi Mahila Mahavidyalaya Rajnandgaon to engage in program of co-operation for mutual benefit.

Article 1

The objective of this MoU is to encourage and support cooperation between Govt. Kamla College and District Badminton Association, Rajnandgaon.

Article 2

The details of each activity developed under this MoU (Training, duration, conditions, financing, distribution of task, condition of admission etc.) will be specified and agreed upon in writing before the respective activity takes place.

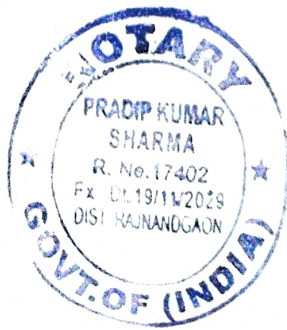
The two parties will each identify a person (“the coordinator”) who will be responsible for the implementation of the co-operative programs under this MoU.

Article 3

Notwithstanding any other provisions, this MoU only expresses the intention Kamla College & Badminton Association These expressed intention are not binding and no legally bonding obligation are intended, or do arise as the consequences the signing of this document.

Article 4

This MoU taken effect upon ratification by the representative of their Institutions, and will be valid for the duration of Three years. After a positive assessment, the MoU can be extended by mutual consent of the parties. The MoU may be terminated upon written notice by either party at any time, and the agreement will terminate 180 days after the date of the written communication of the withdrawal to the partner Institution.
